INDEKSI CIJENA PROIZVOĐAČA INDUSTRIJSKIH PROIZVODA, februar/veljača 2015. godine PRODUCER PRICE INDICES, February 2015

Indeksi cijena proizvođača industrijskih proizvoda u Federaciji BiH su izračunati u skladu sa Klasifikacijom djelatnosti BiH 2010 (Službeni glasnik BiH br. 47/10) i Nomenklaturom industrijskih proizvoda Bosne i Hercegovine 2010 (Službeni glasnik BiH br. 12/11 i 41/11).

Indeks cijena proizvođača industrijskih proizvoda se izračunava na bazi prodaje proizvoda proizvedenih u Federaciji BiH, a prodatih na teritoriji Bosne i Hercegovine (domaće tržište) i izvezenih na inostrano tržište.

The Producer price index in Federation of B&H are calculated according to Classification of activities B&H 2010 (Službeni glasnik BiH br. 47/10) and Nomenclature of Industrial Product B&H 2010 (Službeni glasnik BiH br. 12/11 i 41/11).

The Producer price index is calculated based on production value of industrial products produced in Federation B&H and sold on territory of Bosnia & Herzegovina (domestic market) and exported on non-domestic market.

Ukupan indeks cijena proizvođača industrijskih proizvoda

U februaru/veljači 2015. godine ukupan indeks cijena proizvođača industrijskih proizvoda je viši za 0,6% u odnosu na prethodni mjesec.

Posmatrano prema glavnim industrijskim grupacijama ukupan indeks cijena intermedijarnih proizvoda osim energije je viši za 1,1%, a energije i netrajnih proizvoda za široku potrošnju za 0,3%. Pad indeksa cijena je registrovan/registiran u grupaciji trajnih proizvoda za široku potrošnju za 0,5%, a kapitalnih proizvoda za 0,4%.

Posmatrano prema područjima KD-a, indeks cijena je viši za 0,8% u području Prerađivačke industrije.

U ostalim područjima indeksi cijena se nisu mijenjali u ovom mjesecu.

Posmatrano po oblastima, najveći rast indeksa cijena je registrovan/registiran kod Proizvodnje električne opreme za 5,8%. Najveći pad indeksa cijena je registrovan/registiran u oblasti Proizvodnje motornih vozila, prikolica i poluprikolica za 1,3%.

U ostalim oblastima indeksi cijena se nisu značajnije mijenjali.

Ukupan indeks cijena proizvođača industrijskih proizvoda u februaru/veljači 2015. godine je viši za 2,3% u odnosu na isti mjesec prethodne godine, a u odnosu na decembar/prosinac 2014. godine viši je za 0,3%.

Producer price index-total

In February 2015 total PPI is 0,6% higher in relation to the previous month.

According to the main industrial groupings, the price index of Intermediate goods except energy is 1,1% higher, Energy and Non-durable consumer goods is 0,3% higher. The price index in grouping Durable consumer goods is 0,5% lower and Capital goods is 0,4% lower.

According to the sections of CEA, the price index in the section of Manufacturing is 0,8% higher.

In other sections the price indices were not changed.

According to the divisions of CEA, the highest increase of index is registered in Manufacture of electrical equipment by 5,8%. The highest decrease of index is registered in Manufacture of motor vehicles, trailers, semi-trailers by 1,3%.

In other divisions the price indices were not significantly changed.

Total PPI in February 2015 is 2,3% higher in relation to the same month of the previous year and in the relation to December 2014 is 0,3% higher.

Indeks cijena proizvođača industrijskih proizvoda na domaćem tržištu

U februaru/veljači 2015. godine indeks cijena proizvođača industrijskih proizvoda na domaćem tržištu se nije mijenjao u odnosu na prethodni mjesec, u odnosu na isti mjesec prethodne godine je niži za 0,9%, a u odnosu na decembar/prosinac 2014. godine niži je za 1,0%.

U ovom mjesecu najveći rast indeksa cijena registrovan/registriran je u oblasti Proizvodnje električne opreme za 6,6%. Najveći pad indeksa cijena je registrovan/registriran u oblasti Proizvodnje koksa i rafiniranih naftnih proizvoda za 2,1%.

U ostalim oblastima indeksi cijena se nisu značajnije mijenjali..

Indeks cijena proizvođača industrijskih proizvoda na inostranom/inozemnom tržištu

U februaru/veljači 2015. godine indeks cijena proizvođača industrijskih proizvoda na inostranom/inozemnom tržištu je viši za 1,4% u odnosu na prethodni mjesec, u odnosu na isti mjesec prethodne godine je viši za 7,5%, a u odnosu na decembar/prosinac 2014. godine viši je za 2,2%.

U ovom mjesecu najveći rast indeksa cijena je registrovan/registriran u oblasti Proizvodnje baznih metala za 3,1% i Proizvodnje kože i srodnih proizvoda za 3,0%. Najveći pad indeksa cijena je registrovan/registriran u oblasti Vađenja ostalih ruda i kamena za 4,6%.

U ostalim oblastima indeksi cijena se nisu značajnije mijenjali.

Producer price index on domestic market

In February 2015 PPI on domestic market is not changed in relation to the previous month, in relation to the same month of the previous year is 0,9% lower and 1,0% lower in relation to December 2014.

In this month the highest increase of index is registered in Manufacture of electrical equipment by 6,6%. The highest decrease of index is registered in Manufacture of coke, refined petroleum products by 2,1%.

In other divisions the price indices were not significantly changed..

Producer price index on non-domestic market

In February 2015 PPI on non-domestic market is 1,4% higher in relation to the previous month, in relation to the same month of the previous year is 7,5% higher and 2,2% higher in relation to December 2014.

In this month the highest increase of index is registered in Manufacture of basic metals by 3,1% and in Manufacture of leather and related products by 3,0%. The highest decrease of index is registered in Other mining and quarrying by 4,6%.

In other divisions the price indices were not significantly changed..

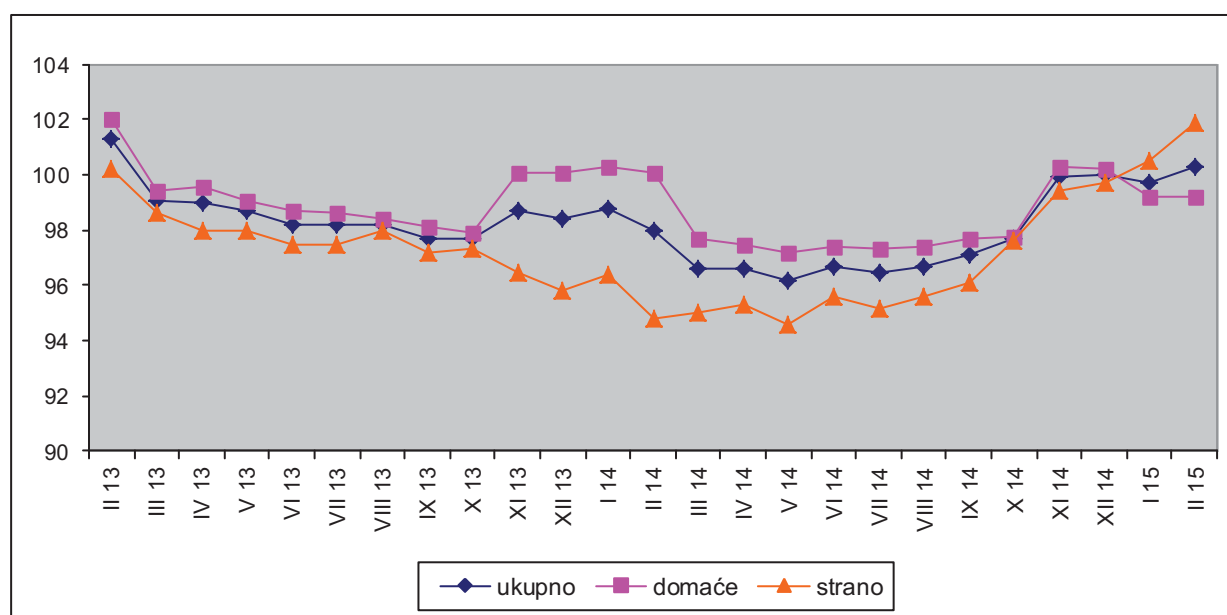

METODOLOŠKA OBJAŠNJENJA

Indeks cijena proizvođača industrijskih proizvoda predstavlja mjeru promjena cijena proizvoda koje industrijska preduzeća proizvode i prodaju na domaćem i inostranom tržištu.

Ukupan indeks cijena proizvođača industrijskih proizvoda sadrži dva podindeksa, tj. Indeks cijena proizvođača industrijskih proizvoda na domaćem tržištu i Indeks cijena proizvođača industrijskih proizvoda na inostranom tržištu. Praćenje prodajnih cijena na ta dva tržišta daje promjene u indeksu cijena proizvođača industrijskih proizvoda ukupne industrije, glavnih industrijskih grupacija, područja i oblasti industrije.

Namjena

Indeks cijena proizvođača industrijskih proizvoda se može koristiti kao mjera inflacije, za očuvanje vrijednosti kod ugovora s indeksnim klauzulama, te kao osnov za deflacioniranje pojedinih makroekonomskih agregata u statistici nacionalnih računa i u druge svrhe.

Obuhvat indeksa

Indeks cijena proizvođača industrijskih proizvoda u Federaciji Bosne i Hercegovine izračunava se na osnovu prikupljenih cijena za proizvode koji se prodaju na domaćem i inostranom tržištu.

Obuhvat proizvoda - Obuhvaćeni su najvažniji proizvodi i usluge koje se proizvode u Federaciji BiH i prodaju na domaćem i inostranom tržištu.

Svakog mjeseca se od izabranih preduzeća prikuplja 1689 pojedinačnih cijena za izabrane proizvode.

Obuhvat preduzeća - Cijene se prikupljaju od 413 proizvodnih subjekata.

Prikupljanje cijena

Cijene se prikupljaju od industrijskih preduzeća mjesečno, putem obrazaca C-41/DOM i C-41/INO.

Ponderi

Ponderi za izračunavanje ukupnog indeksa cijena proizvođača industrijskih proizvoda predstavljaju relativno učešće vrijednosti prodaje pojedinih proizvoda i na domaćem i na inostranom tržištu.

Ponderi koji se primjenjuju za izračunavanje indeksa cijena proizvođača industrijskih proizvoda na domaćem tržištu su koeficijenti koji odražavaju relativno učešće vrijednosti prodaje pojedinog proizvoda u ukupnoj vrijednosti prodaje svih proizvoda na domaćem tržištu.

Ponderi koji se primjenjuju za izračunavanje indeksa cijena proizvođača industrijskih proizvoda na inostranom tržištu su koeficijenti koji odražavaju relativno učešće vrijednosti prodaje pojedinog proizvoda u ukupnoj vrijednosti prodaje svih proizvoda na inostranom tržištu.

Osnovni izvor podataka za izradu pondera je Godišnji izvještaj industrije kojim se prikupljaju podaci o ukupnoj vrijednosti prodaje na domaćem i inostranom tržištu (IND-21).

Za izradu ponderacionog sistema koji je primjenjen pri izračunu indeksa cijena proizvođača industrijskih proizvoda korišteni su podaci za 2010. godinu (bazna godina).

Nova ponderacija se radi svake pete godine, dok se korekcija pondera vrši svake godine. Kao korektivni faktor se koriste indeksi kretanja cijena proizvoda u toj godini.

Klasifikacija i nomenklatura

Za obračun indeksa cijena proizvođača industrijskih proizvoda upotrebljava se Klasifikacija djelatnosti (KD BiH 2010) prema kojoj se poslovni subjekti razvrstavaju u područja B,C,D i E i Nomenklatura industrijskih proizvoda (NIP BiH 2010).

NOTES ON METHODOLOGY

Producer Price index is the measurement of price change for industrial products produced and sold by enterprises on domestic and non-domestic market.

Total PPI is composed of two subindices, i.e. the industrial producer price index on the domestic market and industrial producer price index on the non-domestic market.

Monitoring of selling prices for these two markets provides changes in PPI for total industry, the main industrial groupings, sections and divisions of industry.

Purpose

The PPI can be used as a measure of inflation, to preserve the value of contracts with escalator clauses, as well as a base for deflating macroeconomic aggregates in statistics of national accounts and for other purposes.

Coverage of index

Producer Price index in Federation of B&H is calculated based on collected prices for products sold on domestic and non-domestic market.

Coverage of products - All relevant products and services produced in Federation of B&H and sold on domestic and non-domestic market are covered by this index.

Each month 1689 item prices from selected enterprises are collected.

Coverage of enterprises - The prices are collected from 413 producers.

Price collection

The prices are collected monthly from enterprises by forms named C-41/DOM and C-41/INO.

Weights

Weights for calculating the total PPI represent the relative share of value of sale for each products on domestic market and non-domestic market.

Weights used for calculation of PPI on domestic market are coefficients that represent relative share of value of sale for each product in total value of sale for all products on domestic market.

Weights used for calculation of PPI on non-domestic market are coefficients that represent relative share of value of sale for each product in total value of sale for all products on non-domestic market.

Main data source for calculation of weights is the Annual Survey on Industrial Production used for collecting data on total value of sale on domestic and non-domestic market (IND-21).

For the production of weighting system applied for calculation of PPI, data for 2010 (based year) were used.

The new ponderation has been done each five years, while correction of weights has been done each year. Indices of price movements of products in that year are used as correction factor.

Classification and nomenclature

For calculation of PPI Classification of Activities (CEA B&H 2010) is used by which legal entities are classified in sections B, C, D and E and Nomenclature of Industrial Products (NIP B&H 2010).

Agregiranje

Izračunavanje indeksa cijena proizvođača industrijskih proizvoda počinje izračunavanjem mjesečnih indeksa prostom geometrijskom sredinom za pojedine proizvode koje proizvodi više proizvođača. Agregatni indeksi se nakon toga izračunavaju korištenjem Laspeyres-ove formule za ponderisanu aritmetičku sredinu počevši od indeksa pojedinih proizvoda pa do ukupnih indeksa (ukupnog, indeksa na domaćem tržištu i indeksa na inostranom tržištu), za Federaciju Bosne i Hercegovine.

Agregation

Producer Price Index calculation starts from the computation of monthly average indices for each product produced by the more than one producer, using simple geometric mean. Aggregated indices are calculated by using Laspeyres formula for weighted arithmetic mean starting from the level of representative products to the all indices (total PPI, PPI on domestic market and PPI on non-domestic market) at the level of Federation Bosnia and Herzegovina.
