

PRIKUPLJENO MLIJEKO I PROIZVODNJA MLIJEČNIH PROIZVODA U 2018. GODINI KONAČNI PODACI COLLECTED MILK AND PRODUCTION OF DAIRY PRODUCTS IN 2018 FINAL RESULTS

U Federaciji Bosne i Hercegovine u 2018. godini količina ukupno prikupljenog mlijeka (sve vrste mlijeka- kravlje, ovčije i kozije) manja je za 0,3% u odnosu na 2017. godinu, a količina prikupljenog kravljeg mlijeka manja je za 0,5% u odnosu na prethodnu godinu.

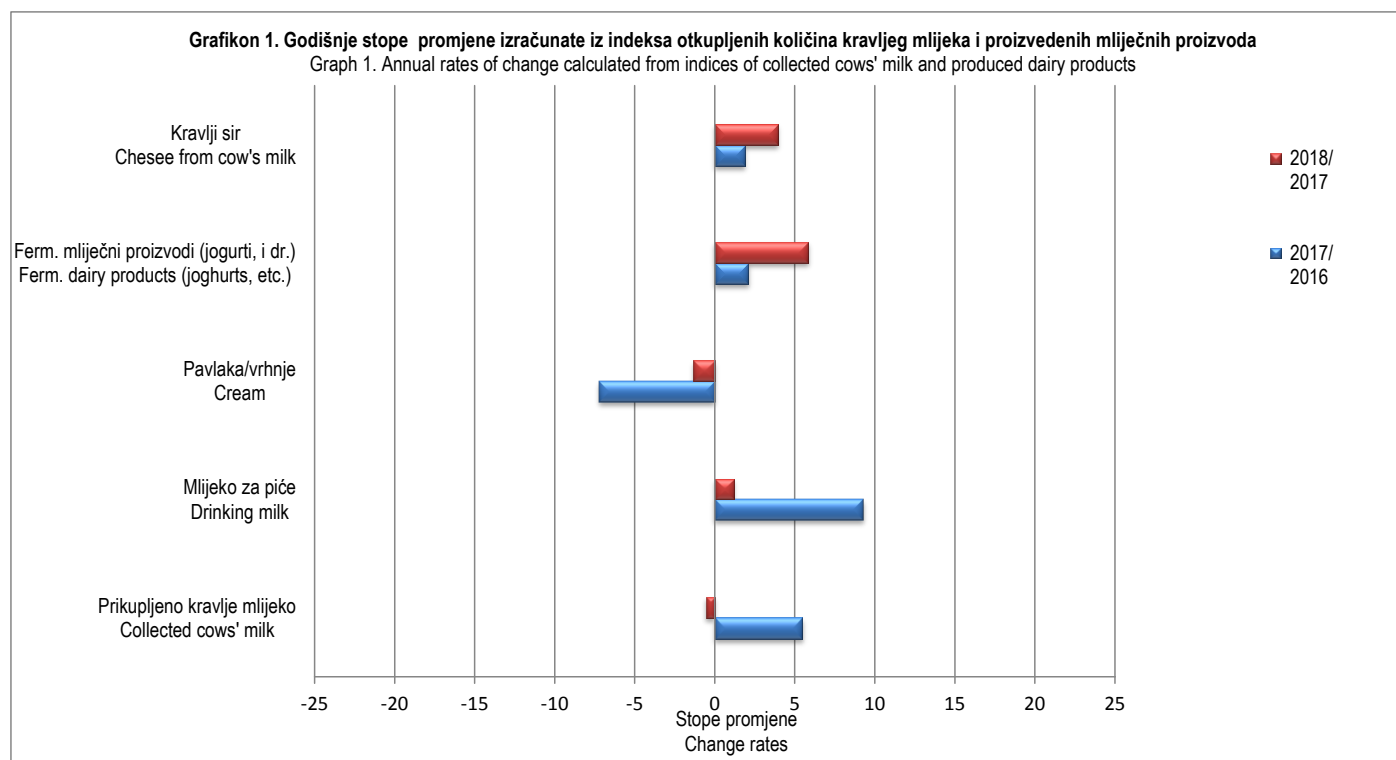
U proizvodnji svježih mliječnih proizvoda porast se bilježi u proizvodnji mlijeka za piće za 1,2% i fermentisanih mliječnih proizvoda za 5,8% dok se pad bilježi u proizvodnji pavlake za 1,4%.

U grupi ostalih mliječnih proizvoda, u odnosu na prethodnu godinu, porast se bilježi u proizvodnji kajmaka za 21,0% i kravljeg sira za 3,9%, dok je pad zabilježen u proizvodnji maslaca za 13,5%.

In the Federation of Bosnia and Herzegovina in 2018 the total quantity of collected milk (cows', ewes' and goats' milk) decreased by 0.3% compared to 2017, and quantity of collected cows' milk decreased by 0.5% compared to the previous year.

In the production of fresh dairy products, compared with the previous year, an increase was recorded in the production of drinking milk by 1.2% and fermented dairy products by 5.8%, while the decrease was recorded in the production of cream by 1.4%.

In the group of other dairy products, compared to the previous year, an increase was recorded in production of kaymak by 21.0% and cow's cheese by 3.9%, while decrease was recorded in the production of butter by 13.5%.

METODOLOŠKA OBJAŠNJENJA

Izvor imetode prikupljanja podataka

Podaci o prikupljenom kravljem, ovčijem i kozijem mlijeku i proizvodnji mliječnih proizvoda prikupljaju se redovnim godišnjim istraživanjem „Godišnji izvještaj o prikupljanju mlijeka i proizvodnji mliječnih proizvoda -sve vrste mlijeka“ (PO-M-MP/G), a na osnovi/telmu Zakona o statistici u Federaciji Bosne i Hercegovine „Službene novine Federacije BiH“, br. 63/03 i 09/09. Ovim izvještajem obezbjeđuju se podaci o količini prikupljenog kravljeg, ovčijeg i kozijeg mlijeka, sadržaju mliječne masti i proteina, te proizvodnji mliječnih proizvoda od kravljeg, ovčijeg i kozijeg mlijeka.

Obuhvat

Izvještajne jedinice su pravne osobe i dijelovi pravnih osoba razvrstani u Područje C, Oblast 10, Grana 10.5, Razredi 10.51 i 10.52 prema KD BiH 2010.

Definicije

Mlijeko za piće obuhvata neobrano, djelimično obrano i obrano mlijeko bez sadržaja aditiva.

Pavlake/vrhne obuhvata prerađenu pavlaku/vrhne koja se koristi izvan mljekara (tj. za ljudsku potrošnju, kao sirovina za proizvodnju čokolade, sladoleda itd.) sa mliječnom masti ne većom od 29%, kao i većom od 29%.

Fermentisani mliječni proizvodi obuhvataju jogurt, kiselo mlijeko, acidofilno mlijeko, te ostale fermentisane proizvode (aromatizirani tečni jogurt ili zakiseljeno mlijeko koji sadrže dodato voće, koštunjčavo voće ili kakao).

Maslac/puter i drugi žutomasni proizvodi obuhvataju proizvode sa sadržajem mliječne masti od 80-90%, sadržajem vode maksimalno 16% i sadržajem nemasne suhe materije do 2%.

Sir obuhvata svježe ili fermentisane proizvode, čvrste ili polučvrste, dobijene koagulacijom punomasnog, obranog ili djelimično obranog mlijeka, pavlake/vrhne, surutkine/sirutke pavlake/vrhne ili mlaćenice, same ili u kombinaciji, djelovanjem sirila ili drugog pogodnog koagulacionog sredstva, i djelimičnim izdvajanjem sirutka/sirutke nastale u takvom procesu.

NOTES ON METHODOLOGY

Sources and methods of data collection

Data on collected cow's, ewes' and goats' milk and production of dairy products are obtained through regular annual survey which is conducted through the report "Annual report on the collection of milk and production of dairy products (all types of milk)", and based on Law on Statistics in Federation of Bosnia and Herzegovina "Official Gazette of FB&H, No. 63/03 and 09/09. This report provides information on quantity of collected cows', ewes' and goats' milk, milk fat and protein contents and the production of dairy products from cows', ewes' and goats' milk.

Coverage

Reporting units are legal entities and part of legal entities classified in Area C, Section 10, Group 10.5, Classes 10.51 and 10.52 according to the KD B&H 2010.

Definitions

Milk drinking (drinking milk): includes the raw milk, whole milk, partly skimmed milk or skim milk and no additives.

Cream: includes the finished product and is available for distribution outside dairies (e.g. for human consumption or as raw material in the manufacture of chocolate, ice cream, etc.) with the fat content no more than and more than 29%.

Fermented dairy products include yogurt, sour milk, acidophilus milk, and other fermented products (flavored liquid yoghurt or acidified milk containing added fruit, nuts or cocoa).

Butter / butter and other yellow fat products includes product having a fat content of 80-90%, a maximum water content of 16% and non-fat dry matter content of not more than 2%.

Cheese includes fresh or mature products, hard or semi-hard, obtained by coagulation of whole, skimmed or partially skimmed milk, cream, whey cream or buttermilk, singly or in combination, by the action of rennet or other suitable coagulation agents, and partial separation of whey incurred in such process.
