

PRIKUPLJANJE KRAVLJEG MLIJEKA I PROIZVODNJA MLIJEČNIH PROIZVODA U FEDERACIJI BiH OKTOBAR/LISTOPAD 2019.

COLLECTION OF COW'S MILK AND PRODUCTION OF DAIRY PRODUCTS IN THE FEDERATION OF BiH OCTOBER 2019

Ukupna količina prikupljenog kravljeg mlijeka u oktobru/listopadu 2019. u odnosu na oktobar/listopad 2018. manja je za 4,3%, a u poređenju sa prosjekom 2018. manja je za 7,8%.

In October 2019, the total quantity of collected cow's milk decreased by 4.3% compared to October 2018, and decreased by 7.8% compared to the 2018 average.

Sadržaj mliječne masti u oktobru/listopadu 2019. u odnosu na oktobar/listopad 2018. manji je za 1,9%, a u odnosu na prosjek 2018. manji je za 1,4%. Sadržaj proteina u oktobru/listopadu 2019. u odnosu na oktobar/listopad 2018. manji je za 2,5%, a u odnosu na prosjek 2018. manji je za 0,4%.

In October 2019, the content of milk fats decreased by 1.9% compared to October 2018 and decreased by 1.4% compared to the 2018 average, while the content of proteins decreased by 2.5% compared to the same month previous year and decreased by 0.4% compared to the 2018 average.

U oktobru/listopadu 2019. u odnosu na oktobar/listopad 2018. proizvodnja maslaca/putera veća je za 42,8%. Proizvodnja mlijeka za piće manja je za 6,4%, pavlake/vrhnja za 7,7%, kajmaka za 26,3%, fermentisanih mliječnih proizvoda za 1,4% i kravljeg sira za 1,9%.

In October 2019, compared to October 2018, an increase was recorded in production of butter by 42.8%, while a decrease was recorded in production of drinking milk by 6.4%, cream by 7.7%, kaymak by 26.3%, fermented milk products by 1.4%, and cow's cheese by 1.9%.

U odnosu na prosjek 2018. proizvodnja fermentisanih mliječnih proizvoda veća je za 2,2%, maslaca/putera za 40,9% i kravljeg sira za 3,8%. Proizvodnja mlijeka za piće manja je za 8,0%, pavlake/vrhnja za 0,6% i kajmaka za 5,7%.

As compared to the 2018 average, an increase was recorded in the production of fermented milk products by 2.2%, butter by 40.9% and cow's cheese by 3.8%, while a decrease was recorded in production of drinking milk by 8.0%, cream by 0.6% and kaymak by 5.7%.

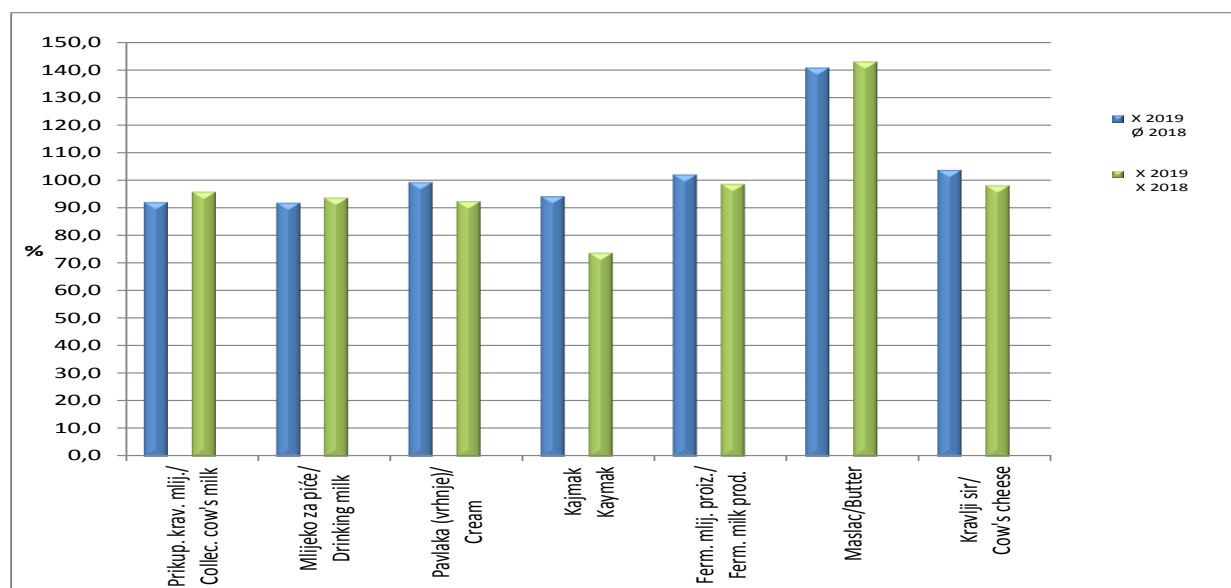

METODOLOŠKA OBJAŠNJENJA

Podaci o prikupljenom kravljem mlijeku i proizvodnji mliječnih proizvoda prikupljaju se redovnim mjesečnim istraživanjem „Mjesečni izvještaj o prikupljanju kravljeg mlijeka i proizvodnji mliječnih proizvoda“ (PO-M-MP/M). Ovim izvještajem prikupljaju se podaci o količini prikupljenog kravljeg mlijeka sa teritorije cijele Bosne i Hercegovine, sadržaju mliječne masti i proteina, te proizvodnji mliječnih proizvoda od kravljeg mlijeka.

Izvještajne jedinice i jedinice posmatranja su pravne osobe i dijelovi pravnih osoba razvrstani prema KD BiH 2010 u djelatnost 10.51-Proizvodnja mlijeka, mliječnih proizvoda i sira.

Definicije

Mlijeko za piće obuhvata sirovo mlijeko, nebrano mlijeko, djelomično obrano mlijeko i obrano mlijeko bez sadržaja aditiva.

Pavlake/vrhne obuhvata pavlaku/vrhne za direktnu potrošnju s više ili manje od 29% mliječne masti.

Fermentirani proizvodi obuhvataju jogurt, tekući jogurt, kiselo mlijeko, acidofilno mlijeko te ostale fermentirane proizvode.

Maslac/puter obuhvata otopljeni maslac/puter, ulje maslaca/putera i slične proizvode s više od 82% mliječne masti.

Kajmak je proizvod sličan maslacu/puteru sa sadržajem mliječne masti manjim od 80%, isključujući ostale masti.

Kravljji sir obuhvata sve vrste sira dobivene isključivo od kravljeg mlijeka (meki, polumeki, tvrdi i ostali sirevi), isključujući topljeni sir.

NOTES ON METHODOLOGY

The data on collected cow's milk and production of dairy products are collected through regular monthly survey which is conducted through the report "Monthly report on the collection of cow's milk and production of dairy products". This report provides information on quantity of collected cow's milk from the whole territory of Bosnia and Herzegovina, milk fat and protein contents and the production of dairy products from cows' milk.

Reporting and observation units are legal entities and part of legal entities classified, according to the KD B&H 2010, in class 10.51- Production of milk, dairy products and cheese.

Definitions

Drinking milk comprises raw milk, whole milk, skimmed milk, semi-skimmed milk and skimmed milk containing no additives.

Cream comprises cream for direct consumption, with fat content more or less than 29%.

Fermented products include yoghurts, drinkable yoghurts, sour milk, acidified milk and other fermented products.

Butter includes melted butter, butter oil and similar products with more than 82% fat content.

Kaymak is a product similar to butter, with fat content less than 80%.

Cheese includes all kinds of cheese produced from cow's milk (soft, semi-soft, hard and other cheeses), excluding melted cheese.
