## ZAPOSLENI<sup>1)</sup>, SEPTEMBAR/RUJAN 2025. PERSONS IN EMPLOYMENT<sup>1)</sup>, SEPTEMBER 2025

U septembru/rujnu 2025. ukupan broj zaposlenih u Federaciji BiH je 547.318. U odnosu na prethodni mjesec broj zaposlenih se povećao za 1,3% a broj zaposlenih žena se povećao za 2,3%.

*In September 2025 the total number of employed persons in Federation of BiH was 547,318. In relation with the previous month the number of employed it increased by 1.3% and the number of employed women it increased by 2.3%.*

Broj zaposlenih u pravnim osobama u odnosu na prethodni mjesec se povećao za 1,6% a broj zaposlenih žena se povećao za 2,6%.

*The number of employed persons in legal entities in relation with the previous month it increased by 1.6% and the number of employed women is increased by 2.6%.*

Broj zaposlenih u obrtu i srodnim djelatnostima u odnosu na prethodni mjesec se smanjio za 0,5% i broj zaposlenih žena se smanjio za 0,6%.

*The number of employed persons in trades and related activities in relation with the previous month it decreased by 0.5% and the number of employed women it decreased by 0.6%.*

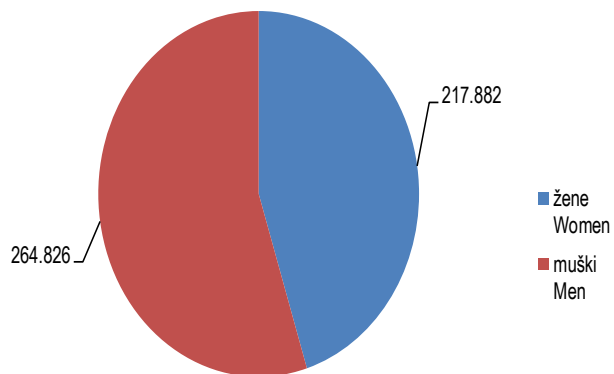

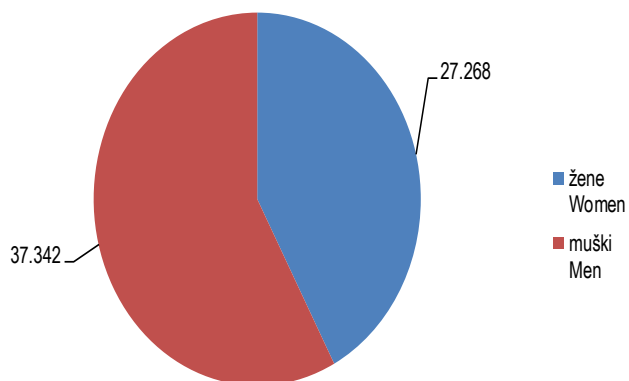

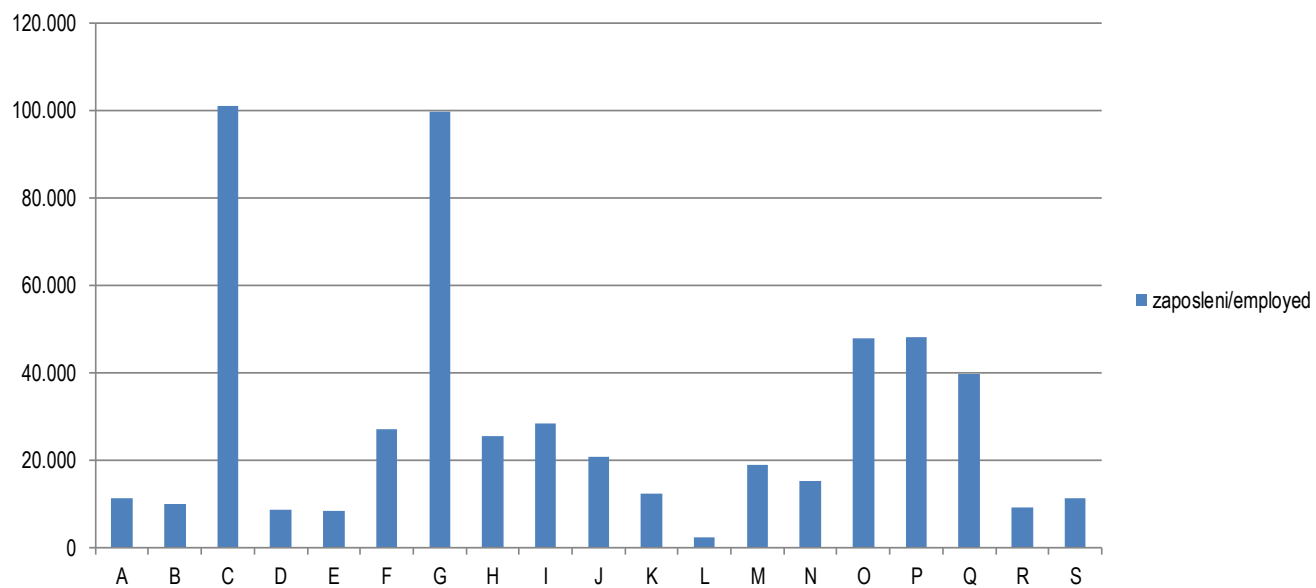

## METODOLOŠKA OBJAŠNJENJA

### Izvori podataka

Podaci o ukupnom broju zaposlenih osoba u Federaciji BiH dobiveni su obradom podataka koji su preuzeti iz administrativnog izvora, Porezne uprave Federacije BiH.

### Obuhvat i uporedivost

U broj zaposlenih osoba u FBiH uključeni su zaposleni u pravnim osobama i obrtu i srodnim djelatnostima.

Istraživanjem su obuhvaćene pravne osobe svih oblika vlasništva, tijela državne vlasti svih nivoa, ustanove i druge organizacije, po organizaciono teritorijalnom principu na nivou općine, koje posluju na teritoriji Federacije BiH.

Istraživanjem o zaposlenima u pravnim osobama obuhvaćeni su zaposleni koji imaju zasnovan radni odnos bez obzira na vrstu radnog odnosa i dužinu radnog vremena.

U ove podatke uključeni su i zaposleni u odbrani i policiji.

Istraživanjem o zaposlenima u obrtu i srodnim djelatnostima obuhvaćeni su zaposleni i vlasnici kojima je obrt osnovno zanimanje.

### Definicije

**Zaposleni** su osobe koje su zasnovala radni odnos s poslodavcem (pravnom ili fizičkom osobom - obrt) na neodređeno ili određeno vrijeme, neovisno od dužine radnog vremena i vlasništva pravne osobe.

**Godišnji prosjek broja zaposlenih** izračunava se kao aritmetička sredina mjesečnih stanja.

## NOTES OF METHODOLOGY

### Sources of data

Data on the total number of persons in paid employment in the Federation of BiH were obtained by processing data that were taken from the administrative source, the Tax Administration of the Federation of BiH.

### Coverage and comparability

The number of employees in FBiH includes employees in legal entities and crafts and related activities.

The survey includes legal entities of all types of ownership, government bodies, institutions and other organizations according to the territorial organizational principle at the municipal level, that operate on the territory of the Federation of BiH.

The survey on persons in paid employment in legal entities includes all persons who have signed a work contract, regardless of the type of work contract and whether they work full-time or less than full-time.

This data including employees in defence and police.

The survey on persons in crafts and related activities includes and employed and owners of craft.

### Definitions

**Employed** are persons who have signed a contract with an employer (legal entities or owners of craft and trade) for a fixed or an unspecified period of time, irrespective of the type of ownership and of whether they work full-time or less than full-time.

**Annual average of the number of persons in employment** is calculated as an arithmetic means of monthly data.
